SUMMARY OF MECHANICS' LIEN LAW FOR ALABAMA

Where a lien arises by virtue of statute there will be different considerations from those raised by a common law or equitable lien, because the primary question will be the meaning of the statute; and it will not necessarily follow that the principles affecting a common law or equitable lien are intended by the statute to apply. Statute law may also destroy or nullify a lien which would otherwise be enforceable.
